Sl. No.	The school is directed to ensure that:
1	The total number of section of the school shall be restricted to 31 on the basis of running sections and as per the number of classrooms of prescribed dimensions reported at the time of inspection. The total number of sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed. Further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft.
2	The seating arrangement is not seen in the labs. The school is directed to make proper seating arrangement in the labs.
3	There are no partitions in boys urinals of one floor. Hence the school is directed to fix the partition immediately and submit the video on SARAS portal within 3 months.
4	CWSN toilets seen in the IC video have no proper handle /support system and are very narrow where the wheel chair cannot be navigated. Hence the school is directed to make the CWSN toilets disabled friendly.
5	The ramp at the entrance and ramp / lift to access upper floor in all the blocks are not seen in the IC video. Hence the school must ensure the CWSN facilities like ramp, separate toilets in each floor of all the blocks. The school is advised to refer circular No.5/2023 for CWSN facilities and submit the compliance within 3 months on SARAS portal.

6	The school has been asked in the last affiliation grant letter to shift the computer lab to a bigger room to maintain the size at least 54 sq mt (600 sq ft) but still it is not done. Hence the school is once again directed to shift the computer lab to a bigger room and and submit the compliance within next 3 months.
7	Sufficient indoor sports facilities not seen in the IC video. Hence the school is directed to make the sports facilities available as per SoP issued by the Board.
8	The school is having 3 building blocks however the building safety certificate covering all the blocks is not uploaded by the school. Only form-D without mentioning building block is uploaded. The school is directed to obtain building safety certificate for all 3 blocks and upload on SARAS portal.
9	As reported by the school, there are 3 building blocks; however the same is not mentioned in the fire safety certificates. The school is directed to obtain fire safety certificate for all 3 blocks and upload on SARAS portal.
10	As per IC report, the Head of sexual harassment committee is male person. The school is directed to replace the committee head with a female person from its faculty list and submit the compliance within next 3 months.
11	There are suggestions from IC for improvement i) store rooms are needed in science labs ii) more books can be added in the library.
12	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6.
